An expert in commercial sales and industry relations, including managing key commodity and grower group relations, he has broad exposure across the agriculture sector, including international farm and animal agricultural study experience in in Europe, Asia, and South America.

His volunteer efforts have benefitted organizations ranging from the World Food Prize and the Iowa Corn Growers to the Farm Bureau and the Chicago Council on Global Affairs.

"Having grown up on a family farm, I know firsthand how Leading Harvest's innovative Farmland Management Standard will help growers achieve sustainability outcomes, providing farmers increased market access while optimizing their operations," said **Andrew Lauver**, **Leading Harvest's director of programs and strategic alliances**. "I am eager to begin working with Leading Harvest and alongside growers to increase awareness, adoption and implementation of the Farmland Management Standard." A graduate of Iowa State University with a degree in agricultural studies, Lauver earned a master's degree in agribusiness from Kansas State University, and a master's degree in jurisprudence in agricultural law and sustainability from the Drake University Law School.
